The two institutions wish to cooperate on an institutional and researcher-to-researcher basis. In the spirit of the traditionally/historically close Ukrainian-Norwegian/Norwegian-Ukrainian cooperation on defence and security issues. The parties will share opinions and information on topics of mutual interest. The parties commit themselves to the following:

Paragraph 1

Based on joint discussion, the two parties yearly identify a particular field of study that is suited for cooperation.

Paragraph 2

The parties will keep each other informed about their research programs and studies. Contact between representatives of the parties will be kept by exchanging letters and holding virtual and physical meetings.

Paragraph 3

The two parties accept to exchange invitations to events (conferences, seminars, symposium, ceremonies, etc.), and assist to promote the convergence between the two parties in accordance with their own missions and tasks.

Paragraph 4

The two parties accept to consider joint research activities (projects publications and conferences).

Paragraph 5

In compliance with the spirit of friendship and cooperation of this Memorandum, each party seeks to give proper technical and cultural support, in accordance with the rules and regulations in force.

In order to carry out research of mutual interest, both parties agree to exchange civil or military researchers. The host will provide the researchers with an adequate workspace and data material in compliance with the regulations in force in the respective countries. A designated representative for the host will facilitate support for vising researchers.

Paragraph 6

In case of cooperation as described in Paragraph 4, a party cannot pass on to a third party any copyright protected information, studies or publications jointly developed without prior written authorization from the other side.

Paragraph 7

Funding of cooperation projects will be carried out by agreement between the parties.

Paragraph 8

This Memorandum comes into effect on the date of the last signature. It remains in effect for a period of one year and is automatically renewed annually. If one party wishes to terminate the Memorandum, this must be done by written communication to be transmitted to the other party with an advance notice of three (3) months.

Any dispute regarding the interpretation or application of this Memorandum will be resolved through direct consultation between the parties
