## Letter of Intent

between the

National University of Defense of Ukraine named after Ivan Chernyakhovskiy and the University of Physical Education, Budapest

The National University of Defense of Ukraine named after Ivan Chernyakhovskiy  
(hereinafter referred to as the University of Defense),  
represented by the Commandant, Dr. mil. s. Anatoly Syrotenko, acting under the Charter of the University of Defense,

and

the University of Physical Education (UPE)  
represented by Prof. Dr. h. c. Lajos Mocsai, Rector, acting on the basis of the Charter of the University,

hereinafter "the Parties", based on the principles of mutual understanding, respect and mutually beneficial cooperation, recognize the need to expand their scientific cooperation for the development of national science and higher education. They express their desire to maintain and expand a sustainable long-term relationship with the aim of efficient use of joint opportunities. The latter includes the implementation of educational, scientific and sport activities, conducting scientific and pedagogical research and implementing the results in education.

### 1. THE SUBJECT OF AGREEMENT

1.1. The subject of this Agreement is the cooperation in the sphere of effective use of the available intellectual and material resources of the Parties.

### 2. DIRECTIONS AND FORMS OF COOPERATION

2.1. Educational and methodological sphere:

- internship and advanced training of scientific-pedagogical and scientific personnel of the Parties;
- development and introduction of new educational technologies, training courses and programs;
- exchange for educational materials, bibliographic and reference books;
- exchange of educational and scientific information;
- preparation and publication of joint scientific, educational, methodological and informational-analytical works;
- advisory work on issues within the competence of experts and scientists of the Parties.

2.2. Research sphere:

- the implementation of joint research projects;
- mutual reviewing research papers, dissertations, methodological materials, textbooks, articles, reports and publications;
- joint conferences, seminars and other scientific events;
- the exchange of scientific informational, reference editions and materials, including electronic copies, which do not contain classified information (the order of such exchange is determined by the Parties).

2.3. Facilitating exchange programs /short term intensive programs:

- the exchange of students, faculty and athletes;
- short term intensive summer programs (faculty led, coaching clinic);
- the exchange of student athletes for friendly games.

2.4. The parties may carry out other activities aimed at achieving the objectives of this Agreement, which does not contradict the current legislation.

### 3. RIGHTS AND OBLIGATIONS OF THE PARTIES

3.1. Parties have the right:

- to initiate the organization and implementation of educational, scientific, sport-related, social and cultural projects;
- to receive information on the activities of each Party directly related to the implementation of this Agreement.

3.2. Parties undertake obligations, such as:

- creating the necessary commissions for the implementation of the areas and forms of cooperation defined in Section 2 of this Agreement;
- informing each other about the organization of joint events: scientific, methodological and practical conferences; pedagogical and methodological seminars;
- co-selecting the candidates for participants of joint projects, informing them about the conditions for participation in such events;
- complying with the terms of this Agreement.

### 4. TERMS AND CONDITIONS OF AGREEMENT

4.1. This Agreement does not impose any financial obligation on the Parties.

4.2. All financial obligations that may arise during the implementation of this Agreement will be issued in separate agreements.

4.3. Changes to this Agreement are made by mutual agreement of the Parties and are drawn up in written supplementary agreements, signed by authorized persons and sealed by the Parties.

4.4. This Agreement shall enter into force on the date of its signature and will be valid for two years. The validity of the Agreement may be continued for the next two-year period, if neither of the parties has stated in written form the intention to terminate cooperation under this Agreement not less than two months before its expiration.

4.5. The contract is made in two copies, one for each of the Parties, which are authentic and have the same legal force.
